- 0620.02 **DECLARATIONS OF INTEREST.** Cllr N M Oliver declared a personal and prejudicial interest in item 0620.07 as a member of Northumberland County Council's Planning Committees.
- 0620.03 **MINUTES.** It was proposed by Cllr Mrs E S Buckley, seconded by Cllr Mrs J Neal and agreed to accept and approve the minutes of the meeting held on 20 May 2020 as an accurate record.
- 0620.04 ACTIONS ARISING FOLLOWING THE MEETING HELD ON 20 MAY 2020.
  - a) **Speeding on Aydon Road.** Minute 0520.09a refers. This will be discussed with Highways on their next visit to Corbridge which will be in the next few months.
  - b) **Update from Corbridge in Bloom.** Minute 0520.09b refers. Corbridge in Bloom now have access to the public toilets to enable them to water the tubs.

## 0620.09 TO RECEIVE REPORTS FROM WORKING/LIAISON GROUPS AND UPDATE FROM CHAIRMAN AND COUNTY COUNCILLOR.

- a) Chairman's Report. Cllr W Clouston gave his verbal report on matters relating to Corbridge.
  - Parish Hall. Work is still ongoing in the Parish Hall. Legally, the Parish Hall can open on 4 July 2020 following the recent government announcement. Before a decision is made to open, Cllr W Clouston will convene a Parish Hall Management Committee Meeting to review and discuss the government guidelines.
  - Play Areas. It was noted that play areas can reopen on 4 July 2020. Mrs M Senior had been carrying out maintenance work during the closure. The annual inspections have taken place and reports produced. There are several minor maintenance issues identified. The work will be carried out before the play areas reopen.
  - **Neighbourhood Plan.** The Neighbourhood Plan is in abeyance due to the current situation as we are unable to carry out any kind of consultation exercise.
  - Railings outside the Co-op. Quotes had been obtained for the replacement railings; £3880 + VAT ungalvanized, £5350 + VAT galvanized, this cost does not include the sandstone water table. NCC had agreed to install the railings and Northern Gas Networks have been asked for a contribution towards the cost. It was AGREED to proceed with the project and progress.
- b) **County Councillor Report.** Cllr N M Oliver gave his verbal report on matters relating to Northumberland County Council and other matters relating to Corbridge Parish Council. This included economic recovery in Northumberland; children returning to school and QEHS rebuild.
  - **Fly tipping**. There had been several reports of fly tipping in and around Corbridge including builders dumping rubbish, young people leaving rubbish on the riverside and an abandoned car in Dilston.
- c) To consider future of Corchester Playing Field. The Parish Council leases this area from English Heritage and any work the Parish Council wishes to carry out would need to be agreed with English Heritage. The pavilion is in a poor state of repair and the proposal is to refurb the pavilion. Cllrs W Clouston and Cllr N M Oliver had met with Steena Steward onsite and she is to provide some sketches of how the pavilion could look. The pavilion will need the roof and fascia boards replaced and the Parish Council would look to open it up, perhaps as a permanent BBQ area. The length of the football pitch will be shortened to move away from the pavilion. The roadside fenced needs to be replaced and signs erected. Several suggestions for improvement were put forward including providing cycle racks, basketball hoop and providing junior size goal posts instead of full size. Outdoor gym equipment had been suggested and this could be funded from S106 funds. It was suggested that the scheme could be funded by the Parish Council and a contribution from Cllr N M Oliver's member funding. It was agreed to proceed with the project. The draft plans will be circulated to all councillors when they are available. Cllr M J Stone joined the meeting.
- d) To discuss speeding on St Helen's Lane and possible monitor by NCC. Cllr M J Stone advised that speeding has increased dramatically on St Helen's Lane recently. He had included information from a private company who provide handheld radar equipment and speed monitoring equipment. Unfortunately, the Community Speed Watch Scheme had been put on hold however Cllr Mrs J Neal had the name of several volunteers who are willing to join should the scheme become available. It was AGREED that Cllr N M Oliver as County Councillor and Cllr W Clouston as Chair to the Parish Council write to Inspector Bridge to request the Community Speed Watch Scheme reopens. Speeding on Newcastle Road was also discussed and cars parking on the pavement which is becoming a problem. Anyone can report cars parked on the pavement that are causing an obstruction to the police. Action: Cllrs W Clouston and N M Oliver to write to Inspector Bridges regarding the Speed Watch Scheme and speed monitoring in Corbridge.

#### 0620.10 ITEMS FOR INFORMATION ONLY

- a) **Table Tennis Club.** Corbridge Table Tennis Club is looking to buy an outdoor table tennis table for the community to use. They would need a sheltered location and a suggestion was made to locate it at the rear of the Parish Hall.
- b) **Riverside.** Several reports of group of young people partying on the north bank of the river had been received. Huge amounts of litter had been left. There are byelaws prohibiting drinking in this area and it was suggested that a sign be erected.
- c) **Corbridge Matters.** Ian Wylie advised that the next edition of Corbridge Matters would be the August edition. The deadline is 20 July 2020. Advertisers are being contacted to see if they need to amend their adverts due to Covid-19.
- 0620.11 **DATE OF NEXT MEETING.** The next meeting of Corbridge Parish Council will be held on Wednesday 22 July 2020 at 7.00pm. It is likely that this meeting will be held online via Zoom however this will be confirmed before the meeting. It was noted that the once the Parish Council can meet face to face this will take place in the main hall where Councillors can sit at a safe distance.
