MINUTES OF THE ANNUAL PARISH MEETING HELD ON 19TH MAY 2021

PRESENT: Cllr W Clouston, Chairman of the Council together with Cllrs Mrs E S Buckley, N M Oliver, C G Curry, M J Stone, Mrs J Neal, S Ahmed, L Stenhouse, L Rogers.

- TO RECEIVE THE MINUTES OF THE 2019 ANNUAL PARISH MEETING. The Minutes of the Annual Parish Meeting held on the 22 May 2019 having been circulated, were signed as a true record. There were no matters arising.
- 2. **PARISH COUNCIL CHAIRMAN'S REPORT**. Cllr W Clouston presented his report on the work of the Council during the past year and looked forward to the next 4 years. Of note, was the refurbishment of the Parish Hall which was completed during the lockdown in 2020. Many of the projects had been postponed due to the pandemic and it is hoped they can be progressed as restrictions are lifted.
- 3. **COUNTY COUNCILLOR'S REPORT**. Clir N M Oliver gave a brief report on his work as a County Councillor over the past year.

Roads. Work had been carried out over the past year with resurfacing of Appletree Lane and work planned for the Crofts Estate (partially completed). Avdon Road and Stagshaw Road.

Local Transport Plan. Local Transport Plan Programme for 2020-21 is currently behind however reports/proposals are expected in the next couple of months on the speeding issues on Newcastle Road and Aydon Road.

Planning. The planning application for the development of 9 houses on Newcastle Road was refused. A large quarry at Anick Grange is expected this year.

Flooding. Work has been completed on the strengthening of the flood defences at the Devils Water.

Devils Water Trail. The trail along the Devils Water was completed last year which included the installation of the new bridge [designed by Marc Horn, former Parish Council chairman].

Community Response to Covid Crisis. The Parish Council in partnership with Visit Corbridge and the Churches had set up the Community Helpline which had 120 volunteers registered. This was operational for 14 months, helping residents with shopping, picking up prescriptions etc. Thanks were expressed to the Clerk who had monitored the helpline and co-ordinated the volunteers.

- 4. **RESOLUTIONS.** There were no resolutions to consider.
- 5. **THERE** being no further matters raised for discussion, the Chairman declared the meeting closed at 7.10pm.

- 521.01 **TO RECEIVE ALL COUNCILLORS' DECLARATION OF ACCEPTANCE OF OFFICE.** All Councillors present made and signed their Declarations of Acceptance of Office in the presence of Mandy Senior, Parish Clerk and Proper Officer of the Council. It was AGREED to accept Cllrs M V Kemp and L Stenhouse's declaration at the June meeting. It was noted that Mark Griffin had resigned from the Council with immediate effect.
- 521.02 **ELECTION OF CHAIRMAN.** It was proposed by Cllr Mrs E S Buckley, seconded by Cllr L Rogers and AGREED Cllr W Clouston be elected Chairman of the Council.
- 521.03 **TO RECEIVE CHAIRMAN'S DECLARATION OF ACCEPTANCE OF OFFICE.** Cllr W Clouston then took the Chair and made and signed his Declaration of Acceptance as Chairman of the Council.
- 521.04 **ELECTION OF VICE CHAIR.** It was proposed by Cllr J Ahmed, seconded by Cllr N M Oliver and AGREED Cllr Mrs E S Buckley be elected as Vice Chair of the Council.
- 521.05 **RESIDENTS** present raised the following matters and where relevant they are listed together with the actions that will be taken, if required. In due course, if necessary, reports will be made back to the Council.
 - a) **Cemetery.** It was questioned whether the maintenance of the cemetery had been resolved. Cllr W Clouston provided an update in his report later in the meeting.
- 521.06 **TO ACCEPT AND APPROVE APOLOGIES FOR ABSENCE.** Apologies received from Cllr Mrs M V Kemp. *Cllr L Stenhouse had been held up and sent his apologies the day after the meeting.*
- 521.07 **TO CONSIDER CO-OPTION TO FILL ONE VACANCY BY MELVYN STONE.** It was proposed by Cllr N M Oliver, seconded by Cllr J Ahmed and AGREED to co-opt Melvyn Stone back onto the Council.
- 521.08 **TO RECEIVE DECLARATIONS OF COUNCILLORS' INTEREST.** Cllr N M Oliver declared a personal and prejudicial interest in item 0521.15 as a member of Northumberland County Council's Planning Committees.
- 521.09 TO CONSIDER ANY MATTERS REQUIRING COUNCIL ACTION THAT MAY ARISE FROM THE PRECEDING ANNUAL PARISH MEETING. Nothing to note.
- 521.10 **TO APPROVE AND SIGN THE MINUTES OF THE COUNCIL MEETING HELD ON 28 APRIL 2021.** It was proposed by Clir Mrs e s Buckley, seconded by Clir M J Stone and AGREED to approve and sign the minutes of the Council Meeting held on 28 April 2021 as an accurate record.
- 521.11 ACTIONS TAKEN FOLLOWING THE MEETING HELD ON 24 MARCH 2021.
 - a) **Access over Corburn.** Minute 0421.13 refers. Cllr N M Oliver is to arrange a meeting with Tim Fish, Public Rights of Way Officer, NCC to discuss in detail.
 - b) **Footpath.** Minute 0421.01b refers. Cllr W Clouston is to speak to the landowner regarding the stile at the bottom of Spoutwell Lane.
 - c) Riggs Play Area. Minute 0421.11 refers. A meeting with Karbon Homes is to be arranged.

- 521.16 **CORRESPONDENCE.** Correspondence and information items received since the April meeting had been listed on the agenda and were noted. (Appendix D). (*Note: wherever possible, all communications addressed to the Council are circulated to Councillors by email for information as and when received).*
- 521.17 **TO APPOINT REPRESENTATIVES ON THE COUNCIL'S VARIOUS WORKING GROUPS.** Councillors AGREED to remain on their appointed Working Groups/Committees for the coming year.
- 521.18 TO RECEIVE REPORTS, IF APPROPRIATE FROM WORKING/LIAISON GROUPS WITH ENCLOSED MINUTES, IF APPLICABLE INCLUDING REPORTS FROM THE CHAIRMAN AND COUNTY COUNCILLOR.
 - a) **Chairman's Report.** Cllr Clouston congratulated Cllr N M Oliver on being re-elected as the County Councillor for the Corbridge Ward. Cllr Clouston then gave his verbal report on outstanding matters and what he hoped to achieve over the next 4 years.
 - **Neighbourhood Plan.** Cllr Clouston had spoken with Jenny Ludman the planning consultant. The Parish Council will restart the Neighbourhood Plan process which had been stalled due to the pandemic.
 - Market Place. The designs/sketches for the redesign of the Market Place are due to be received in the next few weeks. The reconfiguration of the Market Place will be a component of the Neighbourhood Plan. It was noted that there are 2 cars, at the top of the Barclays steps, which are obstructing access for pedestrians. Cllr N M Oliver will contact Andy Olive, NCC to discuss the possibility of a bollard..
 - **North side car park.** The provision of a car park on the north side of Corbridge will be pursued.
 - Corchester Field. Consent for the improvements to Corchester Field and the pavilion had been received. Quotes for new fencing will be obtained. Cllrs W Clouston and N M Oliver are to meet Steena Steward to firm up the design for the pavilion. Once the design has been approved, the Parish Council will obtain costs and look into grants.
 - **New Woodland.** It is hoped the Parish Council can obtain some land to plant a tree for every resident in Corbridge (4200). Cllr W Clouston is to approach local landowners with a view to obtaining a lease. There are grants available nationally for tree planting schemes.
 - Cemetery. Cllrs W Clouston and N M Oliver together with Mandy Senior had met at the cemetery on Monday to inspect the site. The cemetery is generally in good order and Cllr Clouston refuted some of what Mark Griffin had reported. Several areas will be improved including: Gates: Chris Urwin is to repair, strip and repair the main gates. Maintenance gate: Although in good order, it was suggested that the maintenance gate be replaced with a Victorian style, more in keeping with the existing gates. Paths: Generally in good condition however some areas need attention. The clerk will contact Thompsons of Prudhoe for a delivery of granular subbase to spread on any uneven areas. Slabs: There is an area of sandstone blocks which has sunk and needs to be levelled. The clerk will contact some local contractors to attend to. A discussion took place over the use of the chapels. It was agreed to discuss this further. NCC is currently looking into the rates paid by the Parish Council on the chapels. Cllr N M Oliver is pursuing this. It was noted that Jim Hedley, Cemetery Superintendent retires on 4 June 2021.
 - b) **County Councillor's Report.** Cllr N M Oliver gave his verbal report on matters related to Corbridge Parish and the wider County area.
 - **Schools.** Cllr N M Oliver had visited the site of the rebuilding of the new High School in Hexham. This will be a fantastic building with excellent sporting facilities. Corbridge Middle School has 2 new portable classrooms (pods) and a daily mile track is to be installed.
 - **Cycle Track to Hexham.** This is one of the top 2 cycle projects in the County although the project will need landowners' permission.
 - Footpath to Riding Mill. This footpath collapsed in 2015 however is currently being investigated.
 - **Speeding.** This is a significant issue and it is hoped that a 20mph will be created in the centre of the village. It was suggested that the Parish Council look into provided a 2nd speed indicator on Aydon Road. Cllr Mrs Neal had passed the names of volunteers who were interested in becoming speed watch volunteers to Cllr Oliver who had passed the information to Northumbria Police.
 - **Skatepark.** A virtual meeting will be arranged with all interested parties to progress the replacement of the skatepark.

- EV Charging points will be installed in due course.
- **Community Led Housing.** Corbridge Parish Council is the first Parish Council in the country to buy off plan and provide affordable housing to their community.
- Car Park. No further updates on the new south side car park.
- c) Roots of Remembrance. This is a Royal Horticulture Society initiative and is ongoing. Corbridge in Bloom had planted the trees in Corbridge, Aydon Green and Wellbank Green. Cllr Mrs E S Buckley had spoken to the vicar and they will organise a short service in the summer. The clerk will contact Corbridge in Bloom to see if a plaque would be appropriate.
- 521.19 **AGENDA ITEMS FOR THE NEXT MEETING.** It was noted that following Mark Griffin's resignation, there is one vacancy on the Parish Council.
- 521.20 **OPPORTUNITY FOR RESIDENTS TO COMMENT ON ANY ISSUE RAISED.** It was reported that cars are speeding on St Helen's Street. Cllr N M Oliver is to report this.
- 521.21 **DATE OF NEXT MEETING.** The next meeting will be of the Parish Council will take place on Wednesday 23rd June 2021 at 19:00 in Room One of Corbridge Parish Hall.
